Market Update and Portfolio Review Summary – ACG

Ms. Haley Rives, CFA, Director, and Kevin Moore, CFA, representatives of ACG provided the Board with a Global Economic Update and the third quarter results of the portfolio. ACG also provided preliminary portfolio results as of November 2023.

Diversifying Fixed Income Search – ACG

Ms. Haley Rives, CFA, Director, and Kevin Moore, CFA, provided the Board with a Fixed Income Implementation overview. The overview included the process for conducting Multisector and Unconstrained manager searches and the resulting recommendations.

Investment Committee

Upon motion by Ms. Schiller, and seconded by Mr. McKay, the Investment Committee approved the recommendations for new Fixed Income investment managers, selecting the Amundi Pioneer Multi-Sector strategy and the Blackrock Strategic Income Opportunities strategy.

At 1:30 p.m. upon the motion of Ms. Odegard, and seconded by Mr. Koreltz, the Committee voted to adjourn and reconvene the meeting of the Board.

Investment Committee Update and Motion

The Board discussed the Investment Committee's recommendation on fixed income search. The committee recommended that the Board award funds for Amundi Pioneer Asset Management as the Multisector manager and Blackrock as the Unconstrained manager in the Fixed Income portfolio.

Upon the motion of Ms. Odegard, and seconded by Mr. Koreltz, the Board approved the Investment Committee's recommendation.

Executive Director's Report

Mr. Tencick provided the Board with an update regarding various matters relevant to the organization, including updates on the completion of the audit, calendar year end processes, and onboarding the new investment manager, Ares Management.

Economic Interest Statements – Due 12/31/2023

The Board and Staff were reminded that Annual Economic Interest Statements for the Minnesota Campaign Finance and Public Disclosure Board are due to the pension office by 12/31/2023. All statements have been received.

SPPS Update

Ms. Ellis reported regarding SPPS topics. The school board elections resulted in three new members being elected. After the new year, the SPPS Board will appoint a new representative for the SPTRFA Board. The district contract negotiations with the unions are ongoing. The district is facing shortfalls for the next school year following the end of American Rescue Plan funds.

FY2022 & FY2023 Audit Report – Governance Exit Conference

Ms. Stephanie Kuka and Ms. Felicia Tri of the Office of the State Auditor (OSA) presented the FY2022 & FY2023 OSA Governance Exit Conference Report. Ms. Kuka gave a summary of the audit process and results, which included reporting that SPTRFA received an unmodified opinion, with no written findings - the highest level of opinion given.

2023 Actuarial Valuation – GRS

Ms. Bonnie Wurst, Actuary and Senior Consultant, presented an overview of SPTRFA's actuarial valuation and answered questions from the Board.

Legislative Update

SPTRFA Legislative Counsel, Mr. Brian Rice, Esq. of Rice Michels and Walther LLP, discussed the SPTRFA agenda for the upcoming legislative session.

Board Transitions Discussion

The Board discussed options for finding a replacement to appoint to complete Mr. Horton's remaining term.

Upon the motion of Mr. McKay, and seconded by Mr. Koreltz, the Board voted to extend an invitation to Karen Martinson to complete the remaining term for Mr. Horton.

Annual Meeting Proxyholders
